# ISTANBUL LAUNCHES CITY SUMMIT

On 1 August 1994, the **President** of Turkey, His Excellency Mr. Suleyman Demirel, officially launched the Habitat II Conference in the historic city of Istanbul where the Conference will be held in June 1996. Dr. N'Dow, the Secretary-General of Habitat II, attended the launching and met with the President and other high-level Turkish government officials to discuss preparations for the 200 Conference. About government and state officials. members of the diplomatic community, the UNDP Resident Representative and UN Resident Coordinator, Mr. Edward Cain, scholars and members of the media were present.

During his three-day visit, Dr. N'Dow discussed arrangements for the core Conference meetings which will pave the way for organising a range of related roundtables, a Cities' Assembly and a World Fair on "Good Ideas for Cities". Several facilities were visited to determine accessibility and suitability for various Conference functions.

Dr. N'Dow met with government and state officials both in Istanbul

and Ankara. He also presented the "road map" of preparatory activities for the Conference to the representatives of the Turkish Government. The Government of Turkey has assigned the Housing Development Administration to manage the preparations for the Conference.

At the second meeting of the Preparatory Committee for Habitat II, which will take place from 24 April to 5 May 1995 in Nairobi, Kenya, the Secretary-General will present a progress report on international preparations for the Conference and on the arrangements that are being made in the City of Istanbul.

# UN / INTER-GOVERNMENTAL ACTIVITIES \_

# PREPARATORY MEETINGS

The secretariat of Habitat II attended the 2nd session of the Preparatory Committee for the WORLD SUMMIT FOR SOCIAL DEVELOPMENT, which took place from 22 August to 2 September 1994 in New York, and submitted its views with regards to urbanisation, social development and the linkages between the two processes. Relevant portions of the Plan of Action resulting from the Social Summit will be integrated within the Global Plan of Action of the City Summit.

The Secretary-General of Habitat II, Dr. Wally N'Dow, delivered a keynote address at the regional Preparatory Meeting for Habitat II of the *ECONOMIC COMMISSION FOR EUROPE* held in Geneva on 12 September 1994. The meeting was also attended by the Executive Secretary of the ECE, Mr. Jean Bartholot.

Mr. Jorge Wilheim, the Deputy Secretary-General of Habitat II attended the 14TH EAROPH **WORLD PLANNING CONGRESS** (Eastern Regional Organisation for Planning and Housing) in Beijing, China, from September 15 to 21, 1994. Mr. Wilheim delivered the keynote address in which he challenged Asian countries to lead the rest of the world in setting up new urban patterns which are equitable and sustainable. The Deputy Secretary-General also met with the Chinese Vice Minister of Housing and Construction to discuss China's contribution to the Habitat II preparatory process.

The Secretary-General of Habitat II addressed delegates at the 2nd

Annual WORLD BANK CON-FERENCE ON ENVIRON-MENTALLY SUSTAINABLE DEVELOPMENT in Washington D.C. on 21 September, 1994. Later, a video on Istanbul produced by the World Bank was shown to delegates affirming the World Bank's commitment to Habitat II.

## **CAIRO CONFERENCE**



Dr. Wally N'Dow, the Secretary-General of Habitat II, attended the INTERNATIONAL CONFERENCE ON POPULATION AND DEVELOPMENT in Cairo, Egypt, which took place from 5 September to 13 September 1994. The Secretary-General delivered a keynote address which highlighted the need to consider urban and housing issues as an integral part of population policies and strategies.

In his speech to the 15,000 delegates attending the Conference, Dr, N'Dow said that global peace and security could not be achieved in a world where more than a billion people live in absolute poverty without adequate food, clothing and shelter. He warned that unless the urban agenda is addressed with the urgency and attention it demands, the consequences may well engulf the 21st century with a vast array of domestic and international

problems, including increasing homelessness, unemployment, ethnic tension, social disintegration and decaying urban infrastructure.

Describing the UN Population Conference as "the first long step on the road to Istanbul", the Habitat II Secretary-General underscored the need to link population issues discussed in Cairo with urbanisation and shelter issues which will be discussed at Habitat II.

## **ADDITIONAL ACTIVITIES**

**UNESCO** has agreed to organise a Habitat II colloquium on the topic of "Prejudice, Intolerance and Violence versus Solidarity" as part of its contribution to the preparatory process for Habitat II.

The UNITED NATIONS UNIVER-SITY in Tokyo (UNU), has indicated an interest in organising a colloquiumonthe Future of Cities for academic, scientific and research institutions as its contribution to the Habitat II preparatory process.

The UN DEPARTMENT OF DEVELOPMENT SUPPORT AND MANAGEMENT SERVICES (DDSMS) has agreed to undertake a study on Metropolitan Governance as part of its involvement in Habitat II preparatory process.

The URBAN MANAGEMENT PROGRAMME for Asia and the Pacific organised a seminar on housing finance for housing finance institutions in the region. It will also organise a meeting of executive heads of NGOs, academic institutions and local government associations from the region later this year.

At the First Preparatory Committee meeting for Habitat II held in Geneva in April this year, it was decided that focal points or national agencies in each country would be encouraged to establish national steering committees with membership drawn from a broad base of interested groups and representative organisations. Currently 51 countries have already formed national committees or are in the process of doing so.

Several countries have also shown keen interest in participating in, and perhaps hosting, the many UNCHS - organised seminars, technical workshops, colloquia and regional meetings that will take place in 1995.

In addition to these in-country initiatives, UNCHS and the Habitat II secretariat have been discussing Habitat II preparations around the world. Recent activities include:

THE RUSSIAN FEDERATION: UNCHS held a meeting devoted to ongoing UNCHS activities in the region as well as to preparations for Habitat II. Eighteen countries were represented including all CIS countries (Confederation of Independent States) except Kazakhstan.

**SOUTH AFRICA:** A UNCHS team travelled to South Africa, 3 August to 14 August 1994. During this visit, UNCHS staff briefed government officials and other representatives of the South African community on preparations for Habitat II.

**JAPAN:** A Memorandum of Understanding was signed by UNCHS (Habitat) representing the

United Nations and the Tokyo Metropolitan Government regarding the organisation of the World City Conference Tokyo (WCCT '96) and Expo to be held in Tokyo in 1996. This agreement highlights the linkages between WCCT '96 and Habitat II. Contacts were also established with NGOs in Japan regarding awareness-building activities in preparation for Habitat II.

USA: A meeting was held in Washington D.C. between the Secretary General and the Housing and Urban Development Department on national and regional preparations for Habitat II. The U.S. Government has submitted a detailed work programme which includes a series of national events, meetings, studies and activities involving all key actors and stakeholders in housing and urban development.

BRAZIL: During his visit to Brazil in July 1994, the Deputy Secretary-General spoke about the importance of Habitat II with a variety of representatives from different groups involved in urban development.

LEBANON: The Secretary-General presented Habitat II activities and objectives to the Prime Minister and the Government of Lebanon. In addition, a delegation from Lebanon, led by the UNDP Resident Representative, Mr. Hendrik van der Kloet, visited UNCHS (Habitat) headquarters in Nairobi from 29 August to 2 September 1994.

**MEXICO:** Members of the Human Settlements Commission of the House of Representatives of

Mexico consulted with the Habitat II secretariat in Nairobi, 30 July to 6 August 1994 regarding the establishment of the Mexican National Committee for Habitat II.

In addition to the above, briefing meetings were held in COLOMBIA, CHILE, ECUADOR, GERMANY, MALAYSIA, NEPAL and the UNITED KINGDOM.

# PREPARATIONS FOR PREPCOM II

The secretariat has prepared a draft proposal for the organisation of work for the second session of the Preparatory Committee for Habitat II. A number of suggestions and recommendations are being submitted to the bureaux of both the Preparatory Committee and the Commission on Human Settlements, as several items of both agendas are inter-related and will require careful scheduling.

# **FUNDING & SUPPORT**

A number of member governments and international lending Institutions have recognized the importance of Habitat II, and have pledged their support to the Habitat II process. These include the Asian Development Bank, the Inter-American Development Bank, the World Bank, and the Governments of Belgium, Denmark, Germany, Greece, Italy, the Netherlands, Norway, Sweden and the United States.

# **MAYORS' COLLOQUIUM**

UNDP, with UNCHS support, organised a Mayors' Colloquium on Social Development in New York from 18 August to 19 August 1994. The meeting was attended by more than 100 mayors, city associations and government officials responsible for local government from 36 countries.

An earlier UNDP survey of mayors from every continent showed that unemployment constitutes the number one urban problemin cities around the world. The second most serious problem urban residents face is inadequate housing, the survey of 135 mayors said.

The results of the survey, which were discussed at the Mayors' Colloquium, will form part of the UNDP contribution to Habitat II as well as the World Summit for Social Development to be held in Copenhagen, Denmark in March next year. The participants pointed out the close relationship between the "Social Summit" and the "City Summit" and further endorsed the importance of active participation of local government in the Habitat II Conference and its preparatory process.

The colloquium resulted in a Mayors' Declaration on Social Development and Sustainable Human Settlements which, among other things, encouraged all those

present to take part in the preparation, proceedings and follow-up work for the Social Summit and Habitat II.

## **ADDITIONAL ACTIVITIES**

The city of **ABU DHABI** hosted a regional seminar for Habitat II on decentralisation and participation in urban development and management from 9 October to 12 October 1994. The seminar was intended for national focal points of Habitat II, local government representatives and representatives from NGOs to prepare for Habitat II.

"GROUP OF FOUR" The associations of local governments (United Towns Organizations, METROPOLIS, SUMMIT and International Union of Local Authorities) held a meeting in New York on 17 August 1994. The four associations agreed to a common platform, position and participation in Habitat II. The meeting was attended by Mr. Jorge Wilheim, the Deputy Secretary-General of Habitat II. and was followed-up in the course of the Mayors' Colloquium on Social Development (See above).

# BEST PRACTICES IN IMPROVING LIVING ENVIRONMENTS

In 1996, the Habitat II secretariat will organise an international panel


of experts to select BEST PRACTICES which will form part of a dedicated exhibit of Good Ideas for Better Cities at Habitat II in Istanbul. They will also be documented and published by UNCHS (Habitat).

BEST PRACTICES are examples of actions which could serve as useful models from which others could learn and adapt to their own situations. They are actions, initiatives or projects which have resulted in tangible and measurable improvements in the quality of life and in the living environments of people in a sustainable way. These actions may have been initiated by NGOs, local governments, central governments or the private sector.

The actors involved in the selected BEST PRACTICES will be invited to participate in the City Summit and have the opportunity to share their experiences with representatives of governments, local governments, NGOs and CBOs and the private sector attending the Conference.

The selected BEST PRACTICES will be disseminated through Internet, and will be accessible to over 20 million users worldwide.

A total of 35 NGOs were granted accreditation by the First **Preparatory Committee meeting** held in Geneva in April this year. An additional 40 NGOs are in various stages of being granted accreditation. Numerous other NGOs and CBOs have expressed an interest in Habitat II, and many have initiated Habitat II preparations in their cities. countries and regions. Often this has meant establishing partnerships with the private sector, with local authorities, with national government and with other NGOs and community groups. Following is a sample of these activities:

### **COLOMBIA**

Following the Global Forum 1994 in Manchester, UK, members of the Colombian delegation to this Forum committed their organizations to enlist broad-based participation in Colombia's national preparatory activities for Habitat II. delegation included representa- tives of the National University of Colombia and of a variety of Colombian NGOs. Through their networks, these NGOs and academics will disseminate Habitat II information. informing Colombians about what is happening worldwide, and about what they can do to become involved in Habitat II preparations within Colombia. The Third International Convention of Habitat Colombia in Pereira this September was the starting point for these activities.

#### **INDIA**

A 3-day All India Consultation on Habitat II will be hosted by Habitat **International Coalition** (Mexico) and the Asian Coalition for Housing Rights (Bangkok), and will be coordinated by Youth for Unity and Voluntary Action. The consultation, scheduled for 4 January to 6 January 1995, is supported by UNCHS (Habitat) and the Urban Management Programme/Asia Pacific 2000. The national government of India will take part in the consultation and has assured its support for five sub-national consultations on Habitat II.

#### **KENYA**

On 26 August 1994, the Kenya Youth and Habitat Organization (KYHO) hosted a seminar entitled "Bridging the Gap". The purpose of this seminar, supported by the Norwegian mission to UNCHS, was to create a simplified version of Habitat II documentation, to "bridge the gap" between grassroots organizations and communities and the intergovernmental City Summit.

The five-page document resulting from this partnership approach will be used throughout Kenya to facilitate discussion of urban issues and to enhance community involvement in Kenya's preparations for the City Summit. Additionally, KYHO has begun dissemination of Habitat II information by using simple fact sheets and holding informational seminars for Kenyan youth. They

plan to begin production of a Habitat II newsletter, and to coordinate training of trainer workshops, to help community leaders take an active role in the Habitat II preparatory process.

#### "SOCRATIC DIALOGUE"

On September 19, Dr. Wally N'Dow, the Secretary-General of Habitat II, participated a "Socratic Dialogue"— a two-hour video event organised by the World Bank which engages distinguished panellists and a moderator in a hypothetical situation to examine the complexities of an issue. The goal of this particular Dialogue was to make the viewing public more aware of the complexity of urban environmental problems and to illuminate the dynamics of policy-making.

The video will be shown to the staff of the World Bank and other development agencies and institutions, and possibly, broadcast on in the U.S.A.

#### **GLOBAL FORUM REPORT**

The International Institute for Environment and Development (IIED) prepared a background paper for the workshops and presentations of the Global Forum on Sustainable Development which took place in Manchester, United Kingdom, at the end of June 1994. Delegates representing four sectors of society - local

authorities, industry, trade unions and local communities - attended a variety of workshops and presentations, and the final report from Global Forum '94 (available later this year), will be presented to the UN Commission on Sustainable Development and provide insights for Habitat II Conference documentation.

#### **FINANCING STRATEGIES**

A first draft of an initiating brief on developing sustainable financing strategies for shelter and urban development as an integral part of the Habitat II preparatory process was sent to a small number of institutions targeted as potential lead institutions in each region.

The key objectives are: to document successful and/or promising financial instruments to stimulate the flow of resources to meet shelter and urban infrastructure capital requirements beyond Habitat II, and to engage the private sector, external support agencies, international financial institutions, and domestic financial intermediaries in improving financial systems both for housing and urban development by opening new avenues of finance. # **EXTERNAL PARTNERS**

Habitat II has begun a unique participatory process to prepare the documentation for PreCom II. Using a worldwide pool of experts from governments, municipalities, NGOs, private sector, academia and the scientific communities, the Secretariat will incorporate a broad range of comments and ideas into the preparation of these documents.

#### PRESS CLIPPINGS

Two Kenyan dailies (the *Nation* and the *Standard*) carried op-ed pieces on urbanisation and the population equation in September 1994, during the week of the UN Population Conference in Cairo. The articles highlighted the link between urbanisation and fertility in developed and developing countries. The *Nation* also carried an article on housing as a basic human right on World Habitat Day.

The Far Eastern Review quoted Dr. Wally N'Dow in an article on population management in the issue of September 22, 1994.

THE *Earth Times* carried a profile of Dr. Wally N'Dow in its issue of August 26, 1994.
