The Second United Nations Conference on Human Settlements, known as HABITAT II, was designed as a partners' conference. Who are the partners? All the stakeholders, the actors, the builders, operators and users of human settlements, from small villages to huge mega-cities. In other words: governments at all levels, from central to local authorities; the private sector; academics, researchers and professionals; non-governmental organizations (NGOs) and community-based organizations (CBOs); non-profit foundations; labour unions and parliamentarians.

Each partner has a role and a specific way of participating, both in the preparatory process and during the Conference and its parallel activities in June 1996.

Governments

The decision to convene the Conference was made by Governments. Due to the critical importance of the issues to be addressed by the Conference, they also decided that the Conference should be held at the "highest possible level of participation". During the preparatory process, they have set up National Committees, with the representation of all partners. In addition to national activities and consultations, they have prepared, National Reports presenting their National Plans of Action, aimed at achieving better housing and better cities, with a focus on specific actions to be taken over the next five years.

They will participate in the Conference following the United Nations rules of procedure, with each country's delegation participating, and voting on all decisions taken at the plenary and through the Committees set up by the Conference.

Local Authorities

This level of government has a special role in this Conference, for it is directly concerned with the management of human settlements. Local authorities are knowledgeable about the issues to be raised and their support will be crucial for the implementation of the main decisions to be taken by the Conference.

During the preparatory process, they can apply to be represented on the National Committee, whose focal point is often the Ministry of Housing, Public Works, Local Government or Foreign Affairs. Local authorities can also organize their own meetings and prepare their contributions to be sent to the National Committee. Many local authorities have already organized regional and international thematic seminars and workshops, with the direct support of the Habitat II Secretariat.

In addition to the opportunity for local authorities to participate in the Conference itself there will be a major parallel activity of direct relevance to representatives of local authorities: the "**World Assembly of Cities and Local Authorities**" (30 and 31 May).

The World Assembly of Cities and Local Authorities (WACLA) is being organized by a secretariat set up by local authorities and their associations.

The Private Sector

The private sector — including commerce, industry and services — comprise important actors in human settlements. Their role in the Conference is to establish participation in development such that it is sustainable and socially just.

In the preparatory process, many corporations are taking a sponsoring role and are also providing an intellectual contribution to the complex economic and social issues of financing urban development and housing. Many have participated in seminars and are supporting other partners' activities.

Academics and Researchers

Their role is to use their knowledge and critical thinking to ensure the intellectual force of the Habitat Agenda.

During the preparatory process, dubbed "our learning year" by the Secretariat a number of academics and researchers participated on a board of some 500 advisers — offering suggestions on the first drafts of the Habitat Agenda, as well as taking part in more than 60 thematic seminars and workshops.

In Istanbul they may participate in their country's delegation, in the "Habitat Dialogues for the 21st Century" (registration after March 1996), or attend the special **Forum on Human Solidarity** (again apply after March 1996). A **Forum of Academies of Sciences** (31 May to 1 June) is also being organized by the Inter-Academy Panel on Scientific Issues (IAP), which has recently been established by the world's academies of sciences.
