*Annex I***PROPOSED ORGANIZATIONAL STRUCTURE FOR THE THIRD SUBSTANTIVE SESSION OF THE PREPARATORY COMMITTEE FOR HABITAT II**

## Note by the Secretary-General

1. The Committee may find it conducive to the efficient conduct of its work during the third substantive session to adopt the specific organizational arrangements as set out below.

(a) *The Bureau*

2. The bureau of the Preparatory Committee consists of a Chairperson, three Vice-Chairpersons and a Rapporteur, elected with due regard to the principle of equitable geographical distribution among the groups. At the first and second substantive sessions of the Committee two of the Vice-Chairpersons were designated to chair the Working Groups of the Whole referred to below. The remaining Vice-Chairperson assisted the Chairperson of the Committee directly in his duties. The Committee may wish to adopt the same arrangement of work as was done at the first and second substantive sessions.

(b) *Working Groups of the Whole*

3. Bearing in mind the decisions which were taken at the second substantive session of the Committee regarding the organization of the work of its second session, the Committee may find it advisable to establish two Working Groups of the Whole: Working Group I and Working Group II. Working Group I would be given responsibility for item 3 and Working Group II would be given responsibility for item 4 with the remaining items being considered in the Plenary.

(c) *Proposed Timetable*

4. The attached annex II contains the Bureau's suggestions concerning the organizational aspects of and timetable for the third substantive session. In this connection, attention is drawn to the fact that the Bureau has made the following proposals regarding the organization of the session:

- (a) not to have a general debate, following the practice adopted by the Preparatory Committees for other recent global conferences; and
- (b) amendments relating to the draft Statement of Principles and Commitments and the Global Plan of Action (The Habitat Agenda) should preferably be in writing and directed at specific paragraphs of the document;
