Recommendations for mational action /10/

D. Land

The Committee adopted, as amended during the discussion, the text submitted by the Drafting Group with respect to recommendations B.2 and D.1 (A/COMF.70/C.3/L.5).

It was decided that some amendments concerning land should be submitted to the plenary by the interested delegations, since the substance of the amendments was outside the Committee's competence.
